# Former President of Colombia Alvaro Uribe discusses major issues in Colombia and Venezuela

On Nov. 6<sup>th</sup>, former President of Colombia and current Senator presented his views on situation in Latin America, providing an update of the peace negotiations between Colombia and the terrorist group FARC as well as the upcoming elections in Venezuela at the Center for Hemispheric Policy at the University of Miami. University president, Dr. Julio Frenk, introduced Uribe before a packed audience.

Uribe was considerably diplomatic in his appraisal of the situation in both Colombia and Venezuela but his sentiments were very much understood by the audience of professors, executives, reporters and students.

He applauded the work of the opposition groups in Venezuela and their objectives to gain freedom and reverse the decay of the economic environment: Private industry had to be reinvigorated and given back their ability to enjoy free enterprise – the private sector needs to develop jobs for the nation to prosper. However, he was doubtful of any change through the election process since the Venezuelan government would be counting of the ballots.

Uribe commented that Venezuela is now more active in trafficking of drugs with the FARC due to the loss of higher priced oil exports.

Uribe indicated the Colombian scenario as being very complicated because the announced peace agreement with the FARC, supported by Cuba and Venezuela, still has too many pending points not fully agreed upon; especially FARC's surrendering their weapons and the agreement on the terms of punishment for those who have committed atrocities. Mr. Uribe expressed concern these issues would not be easily resolved despite the accommodating efforts of the Santos government. Click here for complete contribution by Florida Chapter Chair Fred

## **Charting a Course for Family Giving**
